

MetroPlusHealth is proud to announce an end of year bonus payment for our providers in assisting members to obtain their key wellness tests/visits.

This incentive is separate from MetroPlusHealth's Pay for Performance (P4P) Program.

MetroPlusHealth is offering an additional bonus payment opportunity to providers that perform the following activities to close quality gaps. The services must be completed between **November 15, 2022 and December 31, 2022**:

Incentive Measure	Incentive Activity	Award Amount
Breast Cancer Screening	Member must have a mammogram	\$50
Chlamydia Screening	Member must receive chlamydia testing	\$50
Kidney Evaluation for individuals with diabetes	Member must have an eGFR (via a basic or comprehensive metabolic panel) and urine microalbumin/creatinine ratio	\$25
Well Baby Visits between 15 and 30 months	Member must have a well visit	\$50

Eligibility Requirements: The 2022 MetroPlus Pay for Performance (P4P) Program eligibility requirements **do not apply** to this incentive. The following must be met to qualify for this incentive:

- Network provider assigned to members that are included in each eligible measure population.
- Network providers worked with MetroPlus to furnish medical records for quality improvement projects.
- Members must be enrolled in Medicaid, CHP, HARP, HIVSNP or EP and eligible for the incentive measures based on NCQA® specifications.

Incentive Payment: Providers will be paid at the TIN level and will receive a single incentive payment that multiplies the award amount by the number of eligible members that received one of the services between November 15, 2022 through December 31, 2022. All claims and supplemental data must be received by March 31, 2023.

DISCLAIMER: Funding to providers under this incentive is separate from, and not subject to, existing contracts between a provider and MetroPlus Health Plan (MetroPlusHealth), including the network participation agreement between MetroPlusHealth and the provider. Because payment under the incentive is separate from payment pursuant to the provider contract, payment under the incentive is within MetroPlusHealth's sole discretion and may be withdrawn or discontinued or capped at any time for any reason, including loss of available state funding. To participate in the incentive, a provider must possess a valid, unencumbered license and be in good standing with all applicable government agencies, including those charged with evaluating possible fraud, waste and abuse. To participate in this incentive, providers must provide data and medical records for MetroPlusHealth HEDIS supplemental data and hybrid medical record collection.
