14 NYCRR PART 590

SUMMARY

The purpose of the attached guidance is to provide you with an overview of the 14 NYCRR Part 590 **Comprehensive Psychiatric Emergency Programs** (CPEPs), and billing requirements for CPEPs.

It will provide guidance in the following areas:

- Defining Services such as Psychiatric Emergency Services (e.g., Triage, Full Emergency Visits, and Extended Observation Bed), and Additional Services such as Crisis Outreach, Peer, and Telehealth Services.
- Describing CPEP Operation Services that relates to the following regulations:
 - 1. Admissions and Discharge (NYCRR Section 590.8)
 - o 2. Staffing (NYCRR Section 590.10)
 - o 3. Case Records (NYCRR Section 590. 12)
 - o 4. Organization and Administration (NYCRR Section 590.6)
 - 5. Statistical Records and Reporting (NYCRR Section 590.14)
 - o 6. Premises (NYCRR Section 590.13)
 - o 7. Billing
- Defining and Describing a CPEP Satellite Facilities and Satellite Staffing
- Defining the following words you will find in the attached document: Collaterals, Co-occurring Disorder, Crisis Outreach, Extended Observation Bed, Full Emergency Visit, Medical Examination, On Duty, Received, Restraint, Satellite Facility, Seclusion, Serious Symptoms, Triage, Triage and Referral, and CPEP Clinical and Professional Staff definitions
