In an updated notice to consumers, the NY State of Health (NYSOH) announced it will **continue** to offer Cost-Sharing Reductions (**CSRs**) for Qualified Health Plans (QHPs) through **December 31, 2026**. These CSRs can lower your out-of-pocket costs, such as copays for doctor visits, coinsurance, deductibles, and the maximum out-of-pocket (MOOP) limit.

These enhanced CSRs will continue for members who are:

1. enrolled in a QHP Silver plan right now, or
2. new enrollees with household incomes between 200% and 400% of the Federal Poverty Level (FPL).

The enhanced NYSOH programs also include continued cost-sharing initiatives for certain Pregnancy-Related Services and Diabetes-Related Services. More information may be found at info.nystateofhealth.ny.gov/costsavings.

Your Options to get these Expanded Cost Sharing Reductions (CSRs)

✓ Switch to a QHP Silver plan

- If you are currently enrolled in our MetroPlusHealth Bronze, Gold, or Platinum plan and would like to switch to our Silver plan, you have until August 31, 2026 to make this change by completing a “Life Status Change” in your application.

✓ Enroll in a QHP Silver health plan

- You still have until August 31, 2026 to enroll in a Silver plan.

✓ Already enrolled in a QHP Silver Plan?

- If you are already enrolled in a Silver plan without enhanced CSRs, you do **not** need to take any action: NYSOH will automatically enroll you in the enhanced CSR Silver plan.
